OFFICIAL RULES**

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN. VOID OUTSIDE FL AND WHERE PROHIBITED.

1. ELIGIBILITY: The 2019 A+ Experience Suite Giveaway Sweepstakes (the "Sweepstakes") is open only to entrants who are legal residents of Florida, 18 years of age or older as of the date of entry. The following persons are not eligible to enter or win: employees of Global Spectrum, L.P. d/b/a Spectra Venue Management ("Sponsor") and each of its respective parents, affiliates and subsidiaries and the advertising and promotion agencies and Prize Providers (as defined below) and the immediate families (spouse, parents, siblings and children and their respective spouses, regardless of where they reside) and members of the households, whether or not related, of each of the above. By successfully transmitting a completed entry form during the Entry Period, you will be entered in the Sweepstakes. LIMIT ONE (1) ENTRY, PER PERSON. Additional entries beyond the specified limit will be void. Sponsor's computer will be the official timekeeper for all matters related to the Sweepstakes. Entries generated by script, macro or other automated means and entries generated by any other means which subvert the entry process will be void. All entry data provided via the Survey Monkey entry form is provided to Sponsor and not to Facebook or Twitter. Entrants must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete and/or inaccurate entries are void. No entries will be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Sponsor.

3. DRAWING: Entries must be received during the Entry Period to be eligible for the drawing. One (1) potential Prize (as defined below) winner will be drawn at random on or about Friday, May 17, 2019 at 5:00 p.m. ET, from among all eligible entries received. Sponsor reserves the right to delay the drawing. The potential winner will be notified via email and/or telephone (in Sponsor's discretion). The potential winner must respond to such notification within forty-eight (48) hours, or he/she will forfeit the Prize (as defined below) and, at Sponsor's sole discretion and time permitting, an alternate potential winner will be drawn at random from among all remaining eligible entries. The potential winner will be required to execute and return, prior to and as a condition of receiving the Prize, an affidavit of eligibility and liability release and, except where prohibited by law, a publicity release. The potential winner must return such releases within four (4) days of date of issuance. The Prize consists of (i) use of one (1) suite (consisting of twenty (20) tickets) at the Addition Financial Arena, in Orlando, FL in connection with one (1) mutually agreed upon publicly ticketed event (i.e., those events which are open to the public and for which a ticket is required for admission) that is scheduled to occur between June 1, 2019 and May 31, 2020, which event the winner will choose from among a list of events offered by Sponsor, (ii) a \$400.00 credit, which the winner may use to purchase food and beverage at the Addition Financial Arena for the suite during the selected event, and (iii) four (4) parking passes for the selected event in a parking lot or garage that is designated by the Sponsor in its sole discretion.
